The Davy Select Trading Plus Account (Execution-Only) is designed for those who are comfortable making their own investment decisions, without financial advice. The account allows you to invest in shares, funds, exchange traded funds ('ETFs'), bonds and cash.

The minimum initial amount to open an account is €500.

Before you complete this application form to open a Davy Select Trading Plus Account (Execution-Only), it is important you have taken the time to read and understand all of the account opening information including the Execution-Only Service Terms which are contained in a separate document and include and incorporate the Terms & Conditions, the Appendices, the Risk Disclosure Statement, the Order Execution Policy, the Schedule of Fees & Charges,

the Conflicts of Interest Policy, the Privacy Notice and the Client Asset Key Information Document to ensure that the Davy Select Trading Plus Account (Execution-Only) is suitable for you.

In order to comply with the Criminal Justice (Money Laundering and Terrorist Financing) Act 2010 and the Criminal Justice Act 2013, we are required to verify the identity of each new client. It is important to note that we will not be able to open an account unless the correct documents have been received.
